8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
9. Bid opening shall be on **December 23, 2020 - 9:00 ~~PM~~ AM** at the given address below. Bids will be opened in the presence of the bidders' authorized representatives who choose to attend the activity. AM
10. The **NIA-MARIIS Division IV** will hold a joint site inspection on **December 14, 2020 - 9:00 AM**. Authorized representatives of all interested parties who have purchased the Bidding Documents are required to attend. A "Certificate of Site Inspection" will be issued by the Project Engineer which shall form part of the Technical Documents to be attached at the back of Omnibus Sworn Statement to be submitted during the bid opening.

Contractors with at least fifteen percent (15%) negative slippage on their on-going NIA contracts at the time of advertisement or posting of the Invitation to Bid of this project to PhilGEPS and NIA Website shall not be allowed to participate in the procurement of Civil Works of this agency (NIA MC 32, s. 2014).

The **NIA-MARIIS Division IV** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
