**Renovation of Division II Motorpool Office**

The *NIA-MARIIS Division II*, through the Capital Outlay Budget (COB) for CY 2020 intends to apply the sum of *Eight Hundred Twenty One Thousand Six Hundred Ninety Pesos & 82/100 (₱821,690.82)* being the Approved Budget for the Contract (ABC) to payments under the contract for 2020-DII-COB#1-SAN MATEO-02, Renovation of Division II Motorpool Office. Bids received in excess of the ABC shall be automatically rejected at bid opening.
