



## INVITATION TO BID

The **NIA-MARIIS Division II**, through the **GAA for CY 2024** intends to apply the sum of **Fifteen Million Four Hundred One Thousand One Hundred One Pesos and Twenty-Five Centavos (₱ 15,401,101.25)** being the Approved Budget for the Contract (ABC) to payments under the contract for **2024-DII-RNIS, Construction of Concrete Lining & Structure along - OC-2, Sta. 0+000- 0+292 (L=292 m) - OMC, Sta. 8+500- 8+528.3 (L=28.3 m) - OMC, Sta. 8+214- 8+216 (L=2 m) - OMC, Sta. 8+218- 8+225 (L=7 m); - A, Sta. 0+115- 0+285 (L=170 m); - C, Sta. 5+005- 5+168 (L=163 m) and Construction of Turn-in Structure @ Sta. 5+024**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **NIA-MARIIS Division II** now invites bids for above Procurement Project. Completion of the Works is required within **45 calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184).
4. Interested bidders may obtain further information from **NIA-MARIIS Division II** and inspect the Bidding Documents at the address given below from Monday to Friday **8:00 A.M. to 5:00 P.M.**

A complete set of Bidding Documents may be acquired by interested Bidders on **January 11, 2024** from the address and website below and *upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty-Five Thousand Pesos (₱ 25,000.00)* The Procuring Entity shall allow the bidder to present its proof of payment for the fees which will be presented in person, by facsimile, or through electronic means.
6. The **NIA-MARIIS Division II** will hold a Pre-Bid Conference on **January 19, 2024 @ 9:00 A.M.** at NIA-MARIIS Division II Conference Hall, San Mateo, Isabela and/or through video conferencing/webcasting via ***meet.google.com/tkv-jeun-fzo*** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address as indicated below, on or before **January 31, 2024 @ 9:00 A.M.** Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.
